## E.ON WILL BE THE FIRST EXCLUSIVE OFFICE TENANT AT BAKERSTREET (HUNGARY)

E.ON Hungária Zrt., the Hungarian unit of the E.ON Group has decided to move its Budapest site to BakerStreet, developed by ATENOR Hungary. E.ON will occupy their new Hungarian headquarters from the second quarter of 2024 on 16,200 sqm, in the first phase of the BakerStreet office campus.

ATENOR'S BREEAM Excellent and Access4You Gold-certified, ESG-proof BakerStreet project is located in the 11th district of Budapest. It will comprise two office buildings with a total leasable area of approx. 42,000 square meters. E.ON will be the first tenant to occupy the campus, as the exclusive office tenant of the 1st phase of the development.

**E.ON and ATENOR** both represent similar values, laying the foundation for an excellent partnership. At the core of both companies' principles is the focus on sustainability and ESG, which is the way to mitigate the negative effects of climate change and to future-proof not only the operations of both organizations, but also our planet.

These technical features, as well as the common values with the developer ATENOR, were the main factors in the decision of E.ON to relocate its HQ offices to the 1st phase of the project.
